Overview

The Republican Party's ongoing pursuit of the proposition that the 2020 Presidential election was somehow stolen is self-destructive and self-defeating. All it does is make us look foolish while it diverts resources from a far more credible and important issue: Black Lives Matters' use of 501(c)(3) tax exempt resources to campaign against President Trump.¹

When Sun Tzu Talks, Intelligent People Listen

Sun Tzu's *Art of War*² is an ancient, and highly regarded, treatise on military sciences. James Clavell (author of *Shogun*) wrote in his translation that the bad outcome of the Vietnam War resulted from the enemy's use of Sun Tzu's principles and the United States' failure to heed them. He added that the gruesome blunders of the First World War were easily identifiable as such from Sun Tzu's book.

Sun Tzu warned, "There are roads which must not be followed, armies which must be not attacked, towns which must not be besieged, positions which must not be contested, commands of the sovereign which must not be obeyed." In addition, "You can be sure of succeeding in your attacks if you only attack places which are undefended. You can ensure the safety of your defense if you only hold positions that cannot be attacked."

This means that it is wasteful and self-destructive to pursue questionable issues that lack credibility among the swing voters who decide most elections. Pursuit of the unfounded conspiracy theory that Barack Obama was born in Kenya was an example of attacking a position that should not have been attacked. Citation of racist and anti-Semitic hate speech on the Obama campaign's moderated web site (2008), including depictions of Jews as "k*kes" and Black

Hillary Clinton supporters as "house n***ers," along with the proven fact that Obama attended a church that, among other things, published libelous material about Israel and the United States. The latter included, respectively, accusations that Israel and South Africa colluded to develop an "ethnic bomb" to kill Arabs and Black people, and that the U.S. invented the AIDS virus—that is, a false accusation of waging biological warfare.

I and other Second Amendment activists, on the other hand, destroyed the Million Mom March (2000) by attacking a position it could not defend; its use of 501(c)(3) tax exempt resources to influence the election. MoveOn.org was rendered largely irrelevant (2006) with similar methods, namely revelation that its moderators approved, or at least allowed to stand, hate speech against Jews (e.g. depiction of Joe Lieberman as "Jew Lieberman"), Catholics ("the Catholics are raping your children") and even implications that Black Soldiers are potential mutineers who might turn their weapons against their officers.

Voters Do Not Believe the 2020 Election Was Stolen

The Hill reports "One-third of Americans believe Biden won because of voter fraud: poll" which means two-thirds of the people do not believe this.³ When we tell a story that people do not believe, we lose their trust and also their votes. All we are doing is reinforcing failure and

BLM Used 501(c)(3) Resources to Campaign Against President Trump

IRS regulations forbid the use of 501(c)(3) tax exempt resources to influence an election. Remember that this was the very issue that shattered the Million Mom March in 2000 despite support from prominent Democrats including Dianne Feinstein, Barbara Boxer, Hillary Clinton, Jerrold Nadler, Nita Lowey, and I believe Charles Schumer. It can be proven that BLM also used 501(c)(3) tax exempt money to influence the 2020 election.

• This is a clear admission that BLM worked intentionally to influence the 2020 election, and the facts show that this took place almost exclusively with the fiscal sponsorship of Thousand Currents and then the Tides Foundation, and with donations flowing through ActBlue Charties—for which the Democratic Party is responsible.

Conclusion

Had the Republican Party followed Sun Tzu's advice to attack a position the opposing side cannot defend—there was no way the Democrats could have defended or justified BLM's use of tax exempt resources to influence the election, let alone their own close connection to BLM—instead of squandering resources and credibility on unproven allegations of election fraud, we might now control the White House and both Houses of Congress. In addition, public revulsion against this and also the litany of riots and devastation under color of BLM (with one BLM leader depicting looting as "reparations") would have probably devastated BLM's credibility and influence totally and taken down every Democrat who associated with it.

We should accordingly drop the "election fraud" issue completely to avoid squandering further resources and credibility, and pursue instead something that will actually work to take back the House and Senate in 2022.
